At this event, we will be honoring the 1,500 volunteers, 4,000 students, and myriad of educators that work with our 39 CISNT programs across Denton and Wise counties. We serve students of limited English proficiency, students from abusive homes, students who are hungry, students who are pregnant or parenting, and students who are homeless. We take children who struggle academically, emotionally, and behaviorally, and we do everything that we can to support and empower them to stay in school and prepare for adulthood, recognizing that they are the ultimate investment in our community’s future. **At CISNT, we are #AllInForKids.**

Our program model has statistically proven outcomes, is cost effective, and is provided free of charge to students identified by Texas Education Agency as being at-risk of dropping out of school. **Each year, 99% of these CISNT students stay in school and remain on track for graduation.** As a 501(C)(3) nonprofit, we rely on community support to provide these essential social services and support resources to children in need throughout the school year.

We are grateful to you for your on-going support of our programs and appreciate your desire to sponsor this event! With over 300 expected attendees, your support will be celebrated in front of our Board of Directors, local business leaders, community members, and representatives of the six school districts we serve in across Denton and Wise Counties.
