

After school programs provide an additional 444 hours of academic enrichment after school annually for each student through the ACE 21st Century Community Learning Center cycle 7 and cycle 8 grants. In order to promote student achievement these programs provide academic assistance activities that include homework completion and tutoring; enrichment activities including mentoring and team building; family and parental support activities that increase parental involvement in their child's education; and college and workforce readiness activities that allow students to explore vocational and college opportunities. During the 14-15 fiscal year, 2,914 students were served in Denton ISD, Lewisville ISD and Little Elm ISD.

Students are referred to the program based on need and CISNT school based Site Coordinators develop an individualized case management plan for each student and their family. The plan incorporates access to intensive services necessary to eliminate barriers to academic success. CISNT Site Coordinators office at the school campuses and utilize a research based, six-component service model which includes: 1. Supportive guidance and counseling; 2. Health and human services; 3. Parental and family involvement; 4. Career Awareness; 5. Enrichment activities; and 6. Educational enhancements. Of the 2,419 students served, 99% stayed in school, 95% promoted to the next grade level and 92% graduated on time.
