Case Management programs are designed to address the academic and social service needs of students identified as at-risk of dropping out of school at 60 school campuses across Denton, Cooke and Wise counties. Students are referred to the program based on need and CISNT school based Site Coordinators develop an individualized case management plan for each student and their family. The plan incorporates access to intensive services necessary to eliminate barriers to academic success. CISNT Site Coordinators office at the school campuses and implement an evidence based model of integrated student supports. Of the 5,621 students served, 100% stayed in school, 99.5% promoted to the next grade level, and 98.4% graduated.

After school programs through the ACE 21st Century Community Learning Center, Cycle 12 Grant offer students an additional 15 hours of academic enrichment afterschool for 29 weeks throughout the school year as well as 20 hours of academic enrichment for 6 weeks during the summer period. In order to promote student achievement, these programs provide academic assistance activities that include homework completion and tutoring, enrichment activities including mentoring and teambuilding, family engagement activities that increase parental involvement in their child's education, and college and workforce readiness activities. During the 2024-2025 fiscal year, 741 students were served enrolled and 516 qualified participated 45 days or more in program in Denton ISD and Lewisville ISD. Additionally, Communities in Schools of North Texas' Afterschool Programs offer students an additional 15 hours of academic enrichment after school, throughout the school year at 3 elementary campuses in Denton ISD. In order to promote student achievement, these programs provide academic assistance activities that include homework completion, enrichment activities, college and workforce readiness, parent involvement, mentoring and executive functioning skills activities. During the 24-25 school year, 210 students were served in the 3 CISNT after-school programs.
